1. <u>Presentation of Dashboard/Disaggregated Data</u> – Amy Lora, Evaluation Lead; Michelle Gross, Director of System Performance.

Q: Have we determined the percentage of child abuse and neglect by race? What is the highest percentage? What are we doing to correct these?

A: We know that white children experience the best outcomes. We have been doing this analysis for three years at a system level. In terms of program level, that is where the strategy comes into play. We are trying to understand the "why" and what we can do about it.

Q: Once we gather this information and you find that certain areas fall short in providing the needs of the community. How do we justify what we are doing to enhance each of these programs?

A: There are different strategies that we have. One of them is by offering individual programs specifically related to child abuse and neglect. We have home visiting programs, such as Healthy Families. We also have our counseling services, like Child First for families that are experiencing trauma to help families work with the stress that they are experiencing to prevent child abuse and neglect. We know that we need to work a little bit differently. Some families are experiencing stress because of an environment, looking at issues such as racism and some of the stressors that communities experience. We are looking at data and understanding what community supports we can offer.

Q: What part does drugs and alcohol plays in the community when you do research?

A: That is one of the top reasons associated with abuse and neglect in families. We look at the root causes for abuse and neglect and a lot of times it is alcoholism and families who are experiencing stress. That is why we need to work together on the health and wellbeing of the community.

That is one of the reasons why we brought Child First to our community. Some of the providers that are doing our home visiting programs are saying that they were seeing an influx of families with domestic violence and substance abuse and they weren't equipped to deal with the intensity of those issues. Child First has been working here for three years. It is also something that we work with the court system so when families have a choice they have an opportunity to go to Child First for therapy that works with the family and children to ensure that they have a safety net and can build capacity to repair trauma so that it doesn't continue generation after generation.

Q: Do we have a large homeless population in Palm Beach County? What are we doing for those kids that are trapped in this situation?

A: Our Board made a policy decision to focus our funding on prevention and early intervention, so we don't offer housing services. We do work with pregnant homeless moms and families that are experiencing homelessness to provide services to them.

Commissioner McKinlay shared that when the one cent sales tax was approved in 2016 in Palm Beach County, they assigned \$25.5 million dollars to homeless services. The County is also looking at approving the second homeless resource center on June 18th. We currently have beds dedicated to families experiencing homelessness. The County also took over one of the family shelters that was closing and is running it. They are also revamping our workforce housing, which is the next step up from low income housing (it is homelessness, low income and workforce). They County is trying to work with our development community to provide more workforce housing and prevent us from sliding into the need for affordable or homeless shelter services. We are trying to redo a lot of our land development codes to allow for some creative housing, she calls them "tiny homes" and are also referred to as "cottage homes". The County will be releasing an RFP for a builder to do a tiny home community. They are working on having the county let go of some of its land in the Glades so that they can do the same there for a dollar or 99 cents a year to lease. We've had more than 600 affordable housing units come out of the ground just in the Glades alone. In addition to that, the County is running the Lewis Center, and she encouraged the audience to reach out to their Mayors and City Council Members to help the county fund this because right now 100% of the funding comes from the county and they need help from municipalities. We are doing a lot, and we recognize that there is such a huge need and no matter how much we put into it, we can't completely eliminate the problem. We are also very dependent on state and federal resources and the legislature swept about \$125 million dollars and funded other corporate programs instead of affordable housing. Most of that money has been allocated. At least 50% to the Panhandle for Hurricane Michael relief, another \$8 million dollars went to a single project in Duval County. The remainder of that will be spread out among the rest of the state. We are seeing our federal resources getting smaller and smaller.

Q: How does this compare with unemployment? What are we doing at the County level to provide opportunities for people to earn a living?

A: Commissioner McKinlay stated that it is not her job to talk about this. It is the job of the private industry to create jobs and her job to provide an environment that is welcoming for businesses to come into our community and to make sure that those businesses provide salaries that are adequate enough to be able to support the housing

for their employees. In the past few years we have had a favorable tax environment here in our County. We do have rising housing costs that is market driven.

Thomas Bean stated that the Florida Chamber Foundation just concluded its Third Annual Prosperity and Economic Opportunity Summit at the Palm Beach County Convention Center. There is certainly a lot of discussion and focus with the alarming data facts that come from the fiscal cliffs. There is interest in addressing changes in policies around it. The following question kept coming up: Is it better to make \$50,000 a year or \$18,000 a year? The fact that that kind of discrepancy could even be up for question was alarming. Once you start hitting a certain income you don't qualify for certain assistance and that creates other financial issues for that person, which can also hold them back from advancing in their professional careers. We need to ask ourselves at a larger scale, how parents can be able to move off from assistance and continue to do better for themselves and their families. It is important to have persistence in the work that we do around this, since this issue will not be solved in one, two or five years, but we have to continue our work by helping address grade reading level and what are our incrementing goals to getting there.

Q: On the orange bar, who are we calling "others white CSC". Is that other children served by CSC Broward or is this other children in the county.

A: These are referred to other children in the county. We use "Propensity Score Matching", which is one of the most rigorous types of evaluation you can do to make sure you're comparing apples to apples and you can see if the impact that you are having is because of the programs you are funding or the system of care. We identify all those factors that make a difference in an outcome and then we match on all those factors.

Q: On birth weight, pre-term and child abuse, how would you say we are doing?

A: Going back to the numbers, when we do matching, it is a subset of everyone we serve and then it gets smaller and the numerators have a greater rate, so there is much more volatility in the numbers. What we can't see here is success stories. For example, there is a situation of a homeless family and the child had serious delays in language and was referred to one of our programs. Despite their homelessness situation and the factors of disadvantage, he was able to reach a point of having a vocabulary and feeling great confidence. If we move that child in the kindergarten readiness direction, that is a success, and we don't see that here. We don't see the movement in these charts even though it is still a success. There are a lot of successes that we can't see in charts.

We recognize that we have a lot of work to do. We continue to look at our outcomes and how we measure. This is our scripted way to look at what we are doing. If you are enrolled in any of our programs that have each of these directed outcomes, you are placed in that group as receiving services, so you may be enrolled and only attended one day and never came back and you are still counted as having received services. Many of our programs have different levels of intensity based on the program model, and they are all grouped together in this particular analysis. When we talk about looking at our healthy births, we also need to look at the health of the mom before she started receiving services.

Q: Is "at least one day" the right question?

A: Our system is set up from a research "intent to treat" perspective so when we come forward and talk about our individual programs, you will hear a lot of success stories. Looking at individual programs, our programs are doing wonderful work and when you roll it all up, since you are including all, even those that are receiving maybe only one phone call or one visit sometimes that can draw the number down. We are trying to figure out whether this is the best way to measure because we have noticed that sometimes this can cloud what we are seeing in the individual programs.

Numbers do matter, and we are trying to show that all this enterprise is worth the investment in the community. We need to push back and clarify what "at least one day" means.

Q: Is there a way to divide the data to show the children that have been in the program for over three months?

A: Yes.

Q: Do you geo code this data so that we can look on a map and see where these families come from and see if there is a trend?

A: We do have the capability to do geo coding and are currently working on that.

Q: Can we partner with the County IS Department and provide that overlay? A: Yes, we will definitely look into it.

Q: Do you see a correlation between the children that are born low birthweight, preterm and being verified? Do you have those numbers, including those that are checking all three boxes?

A: Yes, we will provide these numbers.

Q: In terms of ready for kindergarten, a couple of years ago we were 90% there and now we are down, are we really now at 50%?

A: The measures have been very different. The measure when we were so high was a teacher report of children functioning in many domains. This time it is only focused on early literacy with a little bit of math readiness.

There is a lot of conversation right now on school readiness rates, since they have come out lower. The new school requires children to use a mouse and some of the children have never even seen a computer mouse, as they usually swipe. How they are measuring is not anywhere near what experts in early childhood advise in terms of school readiness. We will provide a full presentation in the near future for the Council for you to all understand the full picture. This is all under House Bill 1091, including the changes that are being implemented to measure school readiness at the state level.

Finance Committee

The Finance Committee met earlier, however, they did not have a quorum. They have a consensus on recommending the Council to approve:

They also reviewed the Investment Policy and this policy is in compliance with all requirements of the Florida statutes, no changes are being recommended.

The Finance Committee had discussion on the Interest Income Projection and the timing of our Annual Investment Performance Review and decided they will review Annual Investment Performance at the end of the fiscal year.

They also discussed the Healthy Start Redesign, which will likely impact our current fiscal year by approximately \$500,000 and the 2019-20 budget by approximately \$1.3 million dollars. The budget will be presented at the June Council meeting.

Fund Balance Policy alternatives were discussed and it was decided to defer a decision.

Q: How small would the mileage increase be?

A: We did not decide on a proposed mileage increase. We were looking at what we had in 2017-18.

Commissioner McKinlay expressed that she is worried about the fiscal constraints in the cities and the county.

Q: We already have the highest mileage increase of all CSCs.

A: In 2000 we went to the voters and received an approval for an additional half mill.

Q: Would this count towards the cities' 10 mil cap?

A: We have our own statute that does not affect any municipality.

Our current mileage is .6403. Last year was .6590. The year before was .6833.

Q: In 2021, we were going to propose 0.6473 or is that with the increase already?

A: The .6473 was what we were going to propose to account for the potential loss we may have in the Healthy Start contract. We were going to look at .6590 next month and see what additional programs we may want to support if we were able to increase mileage.

Q: Is the 0.6473 above what we thought last year we were going to ask for? A: No.

Jose Luis Rodriguez suggested, for future discussion, that we look at the end of year fund balance.

A motion by Rodriguez/Goodman to approve the consensus of the Finance Committee as presented was approved by unanimous vote.

A: It could. It is what people self-report.

Q: What is the additional \$20,000 for?

A: This is a program cost for expansion. It would be for staff that would be entering data, registrations and typical CenteringPregnancy® Program cost.

Q: Does the Council receive a report on outcomes of this program?

A: There was a Prematurity Summit report that was shared as part of the CEO Report, approximately two months ago, that highlighted the recent outcomes from this program.

Resolution #19-018 Agreement with School Board for Mental Health

Assistance

CSC STAFF: Tanya Palmer, Chief Program Officer

SUMMARY:

In 2018, the State or Florida allocated funds to the School District to establish or expand school-based mental health services. The allocation resulted in the Mental Health Assistance Program, a cooperative effort with the School District and mental health agencies, which has increased the availability of colocated mental health providers in the District's highest needs schools. Recognizing that the state funding was insufficient to ensure service provision at each school, CSC expressed our commitment to provide funding for 10 elementary schools located in the BRIDGES catchment areas. This funding was intended to fill the gap until the School District was able to secure additional revenue through the approval of an additional one mill. At the August 2018 Council meeting, the CEO was authorized to enter into any necessary agreements with the School District and select mental health provider(s) for purposes of the Mental Health Assistance Program.

The current agreement between the Council and School Board is set to end September 30, 2019 and both parties are desirous of entering into a new agreement effective October 1, 2019 through June 30, 2020. This timeline provides the School District with time to absorb the contract with the mental health provider, Center for Child Counseling (CCC) that is currently in place with CSC thus ensuring that services will be uninterrupted for School Year 2020. The agreement with the School Board outlines the responsibilities of the District to support the Mental Health Assistance Program, including ensuring a consistent framework for Behavior/Mental Health Services, providing access to required data systems to CCC and sharing results in the aggregate for the Program.

Since approval from the Council for the Mental Health Assistance Program, CCC has successfully placed therapists, two of which were bi-lingual to meet the student population needs, in each of the 10 elementary schools. In some capacity, a total of 1,105 children were served during the course of the 2018-19 school year. Therapists have reported successful student, and in some cases, classroom outcomes. Some school administrators have reported a reduction in discipline referrals for some of the students who were supported by the Program. Therapists are gearing up for the summer break, with nine staff remaining in their schools. The staff are enrolling new children, many of whom will be Pre-K students.

FISCAL IMPACT:

The total cost of funding this item for FY 2019-20 is not to exceed \$420,000, with funds available in the Program Strategy Budget, subject to the Council's TRIM and budget process.

RECOMMENDATION:

I recommend the Council approve Resolution #19-018 authorizing the Chief Executive Officer to enter into an agreement with the School Board for Behavior/Mental Health Services for Students, effective October 1, 2019 through June 30, 2020, in an amount not to exceed \$420,000, subject to the Council's TRIM and budget process.

Resolution #19-003 Authorizing Renewal of an Interlocal Agreement for

CSC to be under the Jurisdiction of the Office of Inspector General

CSC STAFF: Thomas A. Sheehan, III, General Counsel

SUMMARY:

In September 2011, the Council voted to go under the jurisdiction of the Office of Inspector General (OIG) pursuant to an Interlocal Agreement that went into effect January 1, 2012, and has been renewed since then. In 2014, the Interlocal Agreement was renewed for an additional three-year period. All of these agreements were based on the dollar values of specified contract types (from the OIG ordinance) that CSC reported via the LOGER (Local Government Electronic Report) system. As the values of CSC's contracts increased from year to year, the OIG fee increased.

In 2016, the Interlocal Agreement was renewed for an additional three-year period, (subject to renewal each year during this three-year period) with certain modifications. At the time both CSC staff and the OIG and his staff found it difficult to determine key processes to be audited that had not already been looked at by the OIG. Moreover, given the OIG's fiscal situation, the ability to continue to provide CSC with the same level of auditing services as in the past would simply not be possible. This situation led to a revision to the Interlocal Agreement whereby the OIG would not provide audit services to CSC and, in return the price paid by CSC would be reduced by one-third (to be a flat fee for a three-year period, resulting in annual savings of \$57,228 over the amount paid for FY 15-16). The Interlocal Agreement is now being proposed to be renewed for a new three-year period.

At the March 2019 meeting, the Council voted to renegotiate the current price of \$116,191 to make sure it was in line with the cost the OIG incurred providing services to CSC. The OIG was contacted for this information and conducted a review of the records for the last three years. During that period, the OIG time, including operating expenses, dedicated to CSC equates to direct and indirect costs of approximately \$212,526. A subsequent email stated of that total, \$170,021 was for the OIG hotline, intake, and investigations, while \$42,505 was for contracts/procurement oversight. Over the three-year period, CSC's payment to the OIG, at \$116,191, totaled \$348,573 or \$136,047 more than the cost the OIG expended on CSC matters.

Discussions were held to see whether this total dollar amount could be reduced. The Inspector General's desire is to keep a LOGER-originated fee system in place. This approach precluded a decrease in the fee for the services CSC currently receives. However, in an effort to be a good partner for CSC, the OIG is willing to remove one of its services (at our choice) for one-half the current fee. Given the large difference in expenses between Investigations and Contract oversight, and the importance to

the public of keeping Investigations, staff would recommend keeping Investigations and reducing the fee.

The Interlocal Agreement is now recommended by staff to be renewed but only as to investigations, at a fixed annual fee of \$58,095.50 (which over a three-year period amounts to \$174,286.50, an amount very close to the amount expended by the OIG for investigations over the past three years).

FISCAL IMPACT:

The total cost for funding this item for FY19-20 would be \$58,095.50; the funds to support this agenda item are subject to the Council's TRIM budget and millage process. This will be a flat fee continuing for the next two fiscal years, as the Agreement would renew automatically subject to the TRIM and budget process.

RECOMMENDATION:

I recommend the Council approve Resolution #19-003 authorizing the Chief Executive Officer to execute a renewal of the Interlocal Agreement for CSC to be under the jurisdiction of the Office of Inspector General, deleting contract oversight services, for October 1, 2019 – September 30, 2020 in an amount not to exceed \$58,095.50 per year, with two additional years renewal, subject to the Council's annual budget and TRIM Process.

Proclamation Declaring June 2019 as Prenatal to Age Three

Investment Month in Palm Beach County

SUMMARY:

Healthy development for children in the early years, particularly through age 3, provides the building blocks for educational achievement, economic productivity, responsible citizenship, lifelong health, strong communities and successful parenting of the next generation.

Recognizing that new research shows that a child's brain is 80 percent of its adult size already by age 3, Children's Services Council developed the Healthy Beginnings system of care for Palm Beach County children. Its mission is to provide opportunities for children and families to optimize birth, early childhood and family outcomes in a supportive community through prevention and early intervention efforts.

Healthy Beginnings seeks to improve birth outcomes by providing access to direct health and social services for pregnant women whose chances of having a healthy baby are hampered by such risk factors as poverty, limited access to health care, depression, poor nutrition, age, substance abuse, homelessness, domestic violence and more. The system also seeks to reach young children exhibiting developmental or behavioral issues that could hamper later school success. Through early intervention, many such issues can be dealt with prior to the child entering the formal school setting, thus improving opportunities for school success.

During the first three years of life, emotionally nourishing relationships lay the foundation for lifelong health and well-being. By supporting the caring adults who touch the lives of infants and toddlers, we hope to maximize our long-term impact in ensuring all children have a bright future.

Healthy Beginnings is designed to promote healthy births, reduce child maltreatment, and promote children's kindergarten readiness. Within the Healthy Beginnings system, multiple agencies are aligned to work together to deliver specific, cohesive services.

Prenatal and early childhood intervention services may include: access to a medical provider and facilitating access to a funding source for that care; maternal depression counseling and infant mental health support; nutritional information; childbirth and breastfeeding education; and family support services.

Children's Services Council works closely with Palm Beach County, particularly the Youth Services Department in the *Birth to 22: United for Brighter Futures Alliance*, and numerous other local providers and community partners. In addition, CSC supports the National Association of Counties (NACo) and other national organizations that form the National Collaborative for Infants and Toddlers (NCIT), a project of the Pritzker Children's Initiative (PCI). This groundbreaking partnership

works with communities and states across the country to focus on early childhood development for young children from birth to three.

Proclamation Declaring July 8-13, 2019 as Palm Beach County Summer Learning Week and July 2019 as Summer Learning Month

CSC STAFF: Amy Blechman, Program Officer

SUMMARY:

Nearly 100 years of research has proven that children lose ground academically when they are out of school for the summer, and that summer learning loss is measurably greater among lower-income children who lose, on average, more than two months of reading achievement in the summer. For example, 28 percent of Palm Beach County children in grades K-2 showed a drop in reading proficiency in summer 2018, compared to 25 percent in summer 2017. In addition, 87 percent of Palm Beach County children in grades K-2 who are reading significantly below grade level received free and reduced priced lunch in 2018 (compared to 85 percent in 2017), reiterating the correlation between poverty and reading scores locally.

Summer learning loss is cumulative and can leave some children 2½ to 3 years behind their peers by the time they're in fifth grade. This persistent summer learning loss can slow children's progress toward third-grade reading proficiency and worsen the achievement gap with their middle- and upper-income peers.

Palm Beach County can help schools and families address summer learning loss by supporting strong programs that engage more children in summer learning opportunities and by providing access to books during the summer. Research also has shown that the greatest impact for children comes when parents have a supporting role in encouraging the children to read, as well as reading with and to them.

CSC supports summer learning in these ways:

• The Council is dramatically increasing dollars for summer camp scholarships. The most recent years are shown here:

- In partnership with their local libraries, BRIDGES offers a Summer Reading Program to empower parents with tools, resources, and strategies to support their children in reading and avoiding summer learning loss.
- CSC distributed more than 100,000 free books to public school children in Pre-K to 5th grade. This year, students are able to choose a book from a selection of popular and diverse titles including:

Be Who You Are, Dog Man Unleashed, and Champion - The Story of Muhammad Ali. CSC has placed more than 800,000 books in the hands of Pre-K and elementary grade students since the inception of the summer reading celebrations in 2013.

■ In addition to the free books distributed through the schools, "A Book for EveryChild" bookmarks were distributed to approximately 100,000 students in traditional and charter schools grades Pre-K through 5th. This special bookmark includes a list of 17 PBC Library System sites on one side, and a list of summer reading tips. The bookmark also invites the child to come to any branch of the County Library System for a library-sponsored BINGO event.

To further that partnership, CSC also is partnering with the Palm Beach County Library System as the main sponsor of Summer Reading Month in June.

WHEREAS, two-thirds of the achievement gap between lower- and higher-income youth results from unequal access to summer learning opportunities, and

WHEREAS, 28 percent of Palm Beach County children in grades K-2 showed a drop in reading proficiency in summer 2018, an increase from 25 percent in summer 2017; and

WHEREAS, the summer learning loss is measurably greater among children living in poverty who lose, on average, more than two months of reading achievement in the summer; and

WHEREAS, 87 percent of Palm Beach County children in grades K-2 reading significantly below grade level receive free and reduced priced lunch (an increase from 85 percent in 2017), reiterating the correlation between poverty and reading scores locally; and

WHEREAS, this persistent summer learning loss can slow children's progress toward third-grade reading proficiency; can leave some children 2½ to 3 years behind their peers by fifth grade; can account for up to two-thirds of the achievement gap in ninth-grade reading; and can delay or prevent high school graduation; and

WHEREAS, Palm Beach County can help schools and families address summer learning loss by supporting strong programs that challenge children, develop their talents, keep them engaged and expand their horizons; and

WHEREAS, Children's Services Council invested heavily in summer camps scholarships, with the most recent years as follows; and



Chief Executive Officer Report

Program Updates

CSC and Provider Staff invited to present at Quarterly Statewide DOH Call

Children's Services Council (CSC) serves as the fiscal, programmatic and administrative agent for the Healthy Start Coalition of Palm Beach County. This unique relationship allows us to leverage state and federal funding with local CSC revenue to support the Healthy Beginnings System of Care, and ensures integration between the state's universal Healthy Start Prenatal and Infant screening process and our local system of services for expectant families and newborns.

CSC, Healthy Start, and the Florida Department of Health share a joint mission of improving birth outcomes, by addressing conditions that contribute to babies being born too small and too soon. As a part of the contracted deliverables with the Department of Health for the Healthy Start Coalition, we were tasked with developing a *Social Determinants of Health Community Development Plan*. The plan required the identification of how seven social determinants of health – poverty, education, toxic stress, transportation, racism, employment, and housing — impacts birth outcomes in our community. Furthermore, we were charged with increasing community awareness of Healthy Start and local services. The Council's oversight of Healthy Start Coalition PBC allowed us the opportunity to collaborate with CSC funded providers and other system partners to create a plan that addresses each of the determinants of health using existing resources.

At a recent site visit by our DOH contract manager, our Healthy Beginnings entry and nursing staff presented their programs and how they collaborate within our system to support the children and families they serve. This presentation prompted an invitation from the Florida Department of Health, Maternal and Child Health Section to CSC staff and DOH Palm Beach Maternal Child Health Division team to host a statewide webinar. Held on May 14, 2019, our staff and partners presented the integrated maternal and child health services made available by CSC to address the Social Determinants of Health to an audience of county health department and Healthy Start staff statewide.

Delores Haynes, Program Officer presented on behalf of CSC detailing the plan development process. She highlighted the collaboration between Healthy Beginnings System of Care partners, identifying the role each provider plays raising the awareness of the social determinants of health and the various opportunities community stakeholders have to improve outcomes for pregnant and parenting families.

Ellen Steinberg and Kerry-Ann Dixon of DOH Palm Beach provided an in-depth overview of the Healthy Start programs, Healthy Beginning Nurses and the Women's Health Initiative (WHIN) program. They emphasized the history of the program models and the targeted participants. They also discussed the significant collaboration efforts with the entry agencies, Healthy Mothers/Healthy Babies and Home Safe. They concluded by highlighting participant outcomes for each program and the reduction of the Black infant mortality rate for Palm Beach County.

Developmental Screening, Assessment and Referrals:

In FY 2017-18, through the efforts of quality child care, Healthy Beginnings, and Bridges, 11,199 children were screened with an ASQ-3, with a total of 17,596 screens conducted. 15% of the screens indicated one or more domains with a Concern. 2,444 second level assessments were completed, including 365 M-CHAT-R, a screening tool to assess risk for Autism Spectrum Disorder. Subsequently, 139 children were referred to First Step to Success and 382 to Early Steps.

Service Descriptions: Healthy Beginnings (HB)

Home Safe: Entry Agency

The Entry Agency for children and families through the age of five provides screening and assessment services for the Healthy Beginnings System through subsidized child care centers, maternity hospitals, and other community entry points. Child and family services include initial screening, second level evaluations, eligibility determination, developmental monitoring, parent education, referral, linkage and system navigation for Healthy Beginnings System Participants.

211: Help Me Grow Parent Information Line

Help Me Grow is a national model that assists in identifying at-risk children and then helping families find community-based programs and services. The model includes a telephone access point, child health care provider outreach, community outreach and data collection. The Help Me Grow Parent Information Line in Palm Beach County connects young children and families to the Healthy Beginnings array of services and offers families the opportunity to participate in ongoing developmental screening.

Easter Seals: Early Intervention Assessment Team

The Early Intervention Assessment Team conducts a developmental evaluation of children 0-35 months of age who have been referred to the Healthy Beginnings Entry Agency based on a Concern on the ASQ-3 or ASQ-SE-2. The purpose of the Early Intervention Assessment Team is to ensure the families and caregivers of infants and toddlers receive services from the multidisciplinary team in an expeditious manner in the available home-setting environment. A team consisting of a Service Coordinator, an Infant Toddler Development Specialist, and a licensed therapist conduct assessments to assist in the early identification of child developmental delays/disabilities, ensures the completion of an Individual Family Support Plan, and make referrals to the most appropriate program to address concerns.

ARC: Healthy Steps

Healthy Steps is a national initiative aimed at enhancing the quality of preventative health care for young children. Healthy Steps emphasizes a close relationship between health care professionals and parents in addressing the physical, emotional, and intellectual growth and development of children from birth to age 3. The program uses the ASQ-3/SE to conduct ongoing screening at defined intervals.

Home Safe: Growing Smart

A developmental surveillance program that uses the ASQ-3/SE screen at developmental stages during the first two years of life to identify possible developmental/behavioral problems that may otherwise have eluded early detection. If children score at risk on the ASQ-3/SE at any time during the program, they will be referred to the Entry Agency for second level assessment and, if needed referred to the appropriate Healthy Beginnings service.

ARC: First Step to Success

The First Step to Success Program (FSTS) is designed to provide in-home services to families of children 0-5 years of age **who are at risk for an acquired developmental delay** as measured on a standardized assessment tool but do not meet criteria for early intervention programming such as Early Steps or Child Find. Developmental Specialists conduct home visits and use the Hawaii Early Learning Profile (HELP) curriculum-based assessment to address infant mental health and developmental concerns of the family.

Easter Seals: Early Steps

Early Steps, Florida's early intervention system, provides early intervention services and supports to infants and toddlers *with disabilities* and their families in the context of everyday relationships, activities, and places.

Service Descriptions: Non-Healthy Beginnings

BRIDGES

Located in 10 of our most vulnerable communities in Palm Beach County, the BRIDGES are designed to assist with family engagement, coordination of resources, navigation to services, parenting supports, and promoting child development. BRIDGES conduct developmental screening and age-appropriate child development activities to support children with typical development as well as those who are being monitored for possible delays.

United Way: Special Needs Initiative

• Special Needs Equipment Fund

The United Way of Palm Beach County administers the Special Needs Equipment Fund. The fund purchases essentially needed medical equipment for children with special needs, ages 0-17 who reside in Palm Beach County, when no other funding is available. Equipment increases or enhances mobility, communication (speech or hearing), and/or vision, or the equipment is medically necessary. There is an application and review process that includes a letter from a trained medical professional describing the need and purpose for which the equipment will be used. Some commonly purchased items include wheelchairs, strollers, bath and shower chairs, and toileting equipment. For the last eight years, the Special Needs Equipment Fund has been used to purchase equipment for 357 children totaling more than \$840,000.

• Support for afterschool and respite needs

The United Way of Palm Beach County enters into contracts with agencies to provide special needs services that address afterschool and respite needs in Palm Beach County. Performance is monitored and contracts include clearly identified goals and outcomes.

211 Special Needs HelpLine

The Special Needs HelpLine serves as Palm Beach County's single source of information and referrals for families of children with special needs, birth to 22 years of age. It currently handles 250 to 300 calls per month and provides short term case management to approximately 30 families monthly.

Not included in the funding allocation are the following services:

- Ongoing developmental surveillance is also provided to young children served by the Palm
 Beach County Health Department, Healthy Families of Florida, and Parent Child Home Program.
 As this is not a primary function of the programs, the costs associated were not included within
 the funding figures.
- There are children served with CSC Scholarships/School Readiness funding who are Early Steps and Child Find participants.

Communications Update

A Book for EveryChild


For 2019, Communications implemented a social media incentive to engage with Palm Beach County elementary schools and promote the annual book distribution. We invited schools to post photos or videos of their school book event and "tag" CSC. The schools with the most Likes, Shares, Retweets and Comments would receive additional books. Seventeen schools posted either photos or videos of their A Book for EveryChild distributions. Five schools each received an additional 250 bonus books from Scholastic. Our big winner was Jerry Thomas Elementary School in Jupiter, which posted photos on Facebook, Twitter and Instagram, receiving 192 Likes, Shares, Retweets and Comments. The other schools that received extra books are Seminole Trails Elementary (West Palm Beach), Boca Raton Elementary, Starlight Cove Elementary (Lantana) and Lantana Elementary.



New radio outreach

CSC launched new radio programs the week of May 6 on WPOM, one of three Haitian-Creole stations in the county, and WSWN, known as Sugar 900 Radio, which broadcasts solely in the Glades. The radio outreach expanded in June to WPSP, the longest-operating Spanish-language station in the market. All programs are 30-min shows, re-broadcast weekly or bi-weekly. We will work with staff from CSC, providers and community partners to present information and take calls from listeners. The first topic was Voluntary Pre-Kindergarten and access to child care, and we are grateful for help from ELC's Rachel Mondesir (above) and Wanda Figueroa in the Creole and Spanish broadcasts, respectively. The second round of broadcasts on all three stations featured healthy pregnancies and healthy births. The contracts with each station includes 30-second PSAs for CSC, in addition to the programs.



Creole and Spanish Landing Pages for EveryParent

The EveryParent website can be translated – using Google Translate – into Spanish, Haitian Creole, Portuguese and French. We recognize that Google Translate isn't perfect, but it has helped families access tips, advice and local resources. In February, we created and launched special landing pages in Spanish and Haitian Creole (above). These pages provide the phone numbers of our entry agencies, as well as BRIDGES and 211, to ensure families get immediate help if they need it. The pages also explain EveryParent, and let families know that Google Translate is an option if they choose to access the full EveryParent website. We expect to share any non-English or subtitled videos we produce using these landing pages, as well.
