




Early Childhood System of Care

USE OF UNDER EXPENDITURES

At the August Workshop, staff had a chance to receive guidance from Council on priorities for the re-purposing of anticipated under expenditures. The six Council members present were engaged throughout the Workshop. Staff takeaways included the following:

- A considerable amount of the discussion focused on summer camp. Council received an update regarding the estimated use of funding for this year's program. The \$500k set aside earlier by the Council will not be needed by the County, and we are estimating conservatively that \$400k of the \$1.7 million made available through under expenditures will be returned to the Council. There were 1,000 children approved for summer camp scholarships that did not enroll in a camp; 310 of these prospective campers identified on their application that they were either homeless or in foster care. County staff will be undertaking further review to determine what barriers these campers experienced- and what could be addressed in the upcoming year.
- Dr. Robinson indicated that the School District may be able to help connecting with campers who indicate they are homeless on their application.
- Various Council members discussed interest in identifying what summer camps are available, and whether it may be
 possible to create a clearinghouse that parents could access to identify what is available. Ideally, this could be a
 resource used by any parent, regardless of income. Staff was asked to determine what may be feasible and how we
 could provide a resource for parents to understand what questions ask/things to consider when selecting a camp.
- Commissioner McKinlay indicated that she would follow-up with the County's ISS Department to see if there may be ways to automate the PB Post Summer Camp Guide and incorporate lists from other sources.
- Continued support for the County's effort to outreach to camps able to serve special populations: special needs, children who are system-involved, children who are experiencing homelessness.
- Though no cap or limit was established, there was a general discussion on the footprint for summer camp scholarships. Over the last 4 years, CSC funding has grown from \$763,400 to an estimated \$3.4 million.
- Though housing was briefly discussed, there was agreement that housing continues to be outside the scope for CSC funding. There may be opportunities for developers submitting affordable housing applications to partner with CSC and the Early Childhood System of Care on connecting families within their communities with needed wrap-around services.
- Council continued to express interest in the very real issue of fiscal cliff, and appreciated that the child care scholarships funded by CSC dollars will cover families up to 300% of the federal poverty level (family of 3, approximately \$63,000).
- Staff will bring back the information shared in a prior Planning Session on the level of support made available for basic needs, inclusive of funding for hunger relief and access to public benefits.
- In March 2020, staff will bring forward a recommendation for the proposed re-purposing of under expenditures for summer 2020 and the up to amounts associated with child care, summer camp and Great Ideas Initiative.
- The three existing areas of child care scholarships, summer camp scholarships, and Great Ideas Initiative were affirmed.
- No one area of programming was a clear priority, and the Council recognized the benefits associated with each.
- No caps were set for any of the three areas.

 - 1. Discussion of the Council's Role with Respect to the General Counsel

The question posed is whether to change our existing bylaws whereby the General Counsel is hired by and reports directly to the CEO as like all the other CSC employees. Our recommendation is that we make no change to our current bylaws, so that the CEO would continue to have authority to hire and terminate the General Counsel. We make that recommendation based on this procedure being consistent with how other large special districts of government operate. Both the Health Care District, as well as the South Florida Water Management District, operate in the same way we do with their General Counsel being hired by and reporting to the Executive Director or the Chief Executive Officer.

We were asked by a member of the Board to look at increased liability. There is, in fact, increased liability to the Board, although it is minimal. It increases any time you are having an employee reporting directly to the Board.

The other item to consider is that when our General Counsel decided to retire we looked at the position and looked at our three year succession plan that we had in place and the person that was going to be moving into the role and decided to look at her skills and abilities and wanting to have more focus on legislative issues. She has that background, so the position is now General Counsel/Chief of Legislative Affairs.

Given these reasons, that is why we are making this recommendation.

Comment: Dr. Robinson stated that it really disturbed her last month when she realized that the General Counsel reports to the CEO as opposed to the Governing Board and that the recommendation is not brought to the Board for ratification. This is completely different from

what she is used, because we received public dollars and we are under the Sunshine Law, which is operating like a private company. This seems like we are public but not quite public. That is why she is pushing back and why this is being brought forward.

Comment: Jose Luis Rodriguez, Esq. stated that he has looked into this issue and from his perspective he is comfortable with either approach (there were 3 options given), but not with the current approach. Based on his prior experience, he thinks the current approach is not appropriate. He would be comfortable with either approach, the General Counsel being ratified or reporting to the Council or if there is consensus, he is willing to join a consensus of a possible hybrid approach where at least the appointment of the General Counsel has to be brought up and ratified and received with an affirmative role of the Board and the Counsel will continue to report to the CEO. He thinks that because of the issues that a General Counsel addresses with the agency, it should come to the Board for some type of vetting, whether it's reporting to the Board or whether it's being confirmed by the Board and the CEO can decide if this position can be fired for cause, like a City Manager or City Administrator.

He likes the idea of having distance between the General Counsel and the CEO for the simple purpose that he is comfortable with all the players here but, as he says during negotiations, he respects that he is comfortable with this now, but he doesn't know who will be seating in that chair in the future and if he will be as comfortable with them.

Q: Chair Weber asked for clarification from Jose Luis Rodriguez, Esq. asking if he is bringing an option to consider as a variation of the recommendations.

A: Jose Luis Rodriguez, Esq. stated that he prefers option 3 but he is willing to compromise and join consensus for option 2 if that is the Board's agreement. He doesn't like the current system of being strictly hired and fired by the CEO because of the nature of this issue.

A motion by McKinlay/Kroll to approve a bylaw change to include the need for ratification of the hiring of the General Counsel and termination to be decided by the Chief Executive Officer was presented.

Q: How does that impact the current hiring? Would this be for future hiring?

A: It depends on when you have this go into effect.

Q: Technically, this person has been announced but not appointed, right?

A: Officially, she takes the position 50% by August 15 and moves into 100% by October 1^{st,} as there is a transition period that we have built into this plan.

Comment: Jose Luis Rodriguez, Esq. proposed to follow whatever works best administratively. We either make this change effective immediately so that the new General Counsel has to be ratified by the Board, or if that is not an option time wise, that we delay the appointment of the new General Counsel by a month or two so that if the bylaws take effect in October 1st, then at that time it would be confirmed. If willing to make this change, the next person will be here for 20 years and he thinks this change should come to the Board and the Board should have an opportunity to speak to that person individually and assess that person for themselves and confirm or not confirm. He would reserve the right to talk to the candidate that is being proposed for ratification.

Comment: Thomas Bean stated that in that regard, he would be in opposition to this change. He is ok with changes for the future because everything has followed according to the current bylaws, there was transition and succession planning and from everything he can tell has been done correctly and properly and with great thought. He thinks there should not be a delay that could impinge on that and opens up the Council to other issues. He has no issues from changing the bylaws to make that change to option 2 moving forward. He has concern making this change retroactive.

Q: Jose Luis Rodriguez, Esq. asked if there is anything in the current bylaws that prevents us from making what we vote on this change today to make in effect tomorrow?

A: That is correct.

Comment: If we make this change effective tomorrow, that person can be brought up in two weeks or four weeks at the next Council meeting for ratification. It doesn't change the process, the transition remains the same, that person if confirmed and would transition. His concern is that there is low turnover at the CSC. People at the Executive positions stay here for 10, 15, 20 or 30 years. If we are not going to get a chance to weigh on this appointment, why make the change? It could be a decade before we get to weigh in. His proposal is that once this becomes effective, upon ratification, the person is brought into transition.

Comment: Commissioner McKinlay stated that as the maker or the motion, she would not be willing to do this as suggested by Jose Luis Rodriguez, Esq. The motion would be on appointments moving forward. The woman who is taking this position was announced at a meeting and we all had an opportunity to voice our concerns and nobody voiced any opposition to that appointment. She is supposed to come on board later this month even if it's in a part-time role and we missed the boat. Her motion still stands as option 2 on all appointments moving forward, not to the current appointment that is coming on board later this month.

Judge Kathleen Kroll stated that she withdraws her second if it's not as the Commissioner stated. She agrees with approving changes to the bylaws moving forward.

Q: Have we had a conversation with the Florida Commission on Ethics? What about other CSCs throughout the state, are they structured in the same way?

A: Other CSCs have contracted out with costs of the smaller CSCs between \$12,000 - \$250,000 and they report to the Board. They are contracted outside, so they are not employed by the CSCs.

Comment: Dr. Robinson's issue is not about the individual. She thinks the process is messed up. She already had a conversation and doesn't want to get into details of how she thinks this is wrong. This procedurally needs to be repaired. She agrees because we need to ratify the person that is coming forward. She has never seen the Council vote against a recommendation from the Executive Director. Procedurally, she will not support the motion on the table. We need to ratify the person who will be stepping in the role if only procedurally. She believes she saw something on the Commission on Ethics or the Florida Bar rules that she still has not received in writing and it's about attorneys reporting to Boards. She knows that none of us here are experts in this area and we need to at the bare minimum ratify the person walking into that position and even after we do that we need to ask a higher authority about this.

Thomas Sheehan, III, General Counsel stated that there is a provision in the Code of Ethics for government lawyers essentially with outside law firms that deals with conflicts. To his knowledge with respect to the Code of Ethics it would apply to the General Counsel, as it applies to all the employees. To his knowledge, there is nothing that the Commission on Ethics would be able to provide to the Council and he has never seen them give an advisory opinion in effect of what they consider best practices for this.

Q: Have we spoken with the Florida Commission on Ethics?

A: No, we have not asked them.

Comment: Dr. Robinson wants to know that her concern is hyperbolic. She needs to know from a higher authority or from a person who lives in that world what the relationship between the General Counsel and the governing board and CEO ought to be. There is nobody in this room that has the expertise to tell her that.

Comment: Jose Luis Rodriguez, Esq. stated that in terms of the liability of the General Counsel reporting or not reporting to the Board and if it reports to the Board it slightly increases liability, at the end of the day, if something happens, it will be everyone on this table, including the Executive Director, that will be sued. No one is ever going to say because the General Counsel reports to the CEO I am not going to name the Board members in the lawsuit, so that issue to him is not an issue. The other issue is that again, nothing against the candidate that was mentioned to be General Counsel, not reflective of Lisa's leadership, not reflective of Tom's abilities as General Counsel, one of the issues that presents is that under the right circumstances, a General Counsel independence could be impaired when you have a General Counsel who is reporting to a CEO and who may have advice that conflicts with the CEO's preferred option and not having an escape valve of reporting to the Board. You would think and you would hope that a General Counsel would take their ethical obligations more seriously and if they conflict with the CEO, do something about it, but when you report to your boss it's very difficult, especially at the Executive level, to say no to your boss, so that is one of things that weighs in favor of option 3, but option 2 is a little bit better.

Comment: Thomas Sheehan, III, General Counsel, stated that with respect to liability, he would agree in terms of the initial suit, since probably all Council members would be named, but given the process that we have, he believes we could get you out of the lawsuit fairly quickly. Regarding the issue of liability, he did go to our employment lawyer to discuss this with him and what you are seeing in the agenda is the employment lawyer's opinion on this. That was his belief too, but he is not an expert in this area, so he reached out to verify that.

Comments: Chair Weber clarified that we have the motion from Commissioner McKinlay and second by Judge Kroll to approve option 2 with the clarification that it will be effective moving forward and it would not affect the current change to the General Counsel position.

A motion by McKinlay/Kroll to approve option (2) presented by staff was approved by four members. Debra Robinson, M.D. and Jose Luis Rodriguez, Esq. voted against.

Discussion took place clarifying that a majority of the Board is needed to change the bylaws.

A motion by McKinlay/Weber to reconsider this decision was approved by five members. Jose Luis Rodriguez, Esq. voted against.

A vote on the original motion to approve option (2) going forward was approved by five members. Jose Luis Rodriguez, Esq. voted against.

Dr. Robinson wanted the record to show that she only changed her vote because even this option is better than what has existed.

8. Chief Executive Officer's Report

Discussion on a request to create a process whereby individual Council Members could submit questions on agenda items and have them answered prior to the Council meetings.

We had a process whereby when a question was asked if the Council member wanted that information shared, we included it in our CEO Report. There was a request to share information about agenda items out to all the Board members prior to the meeting. We have created an email address: Agendaitem@cscpbc.org and any questions specifically related to an agenda item on the packet will go to Tom, Lisa and Elsa so we will be able to get that information, send it all out to the Board before the next Board meeting. If in the rare occurrence it comes in too late or it takes a little longer to gather that information, we will make sure that that information is brought to the Council meeting before there is a vote on that agenda item, but we don't feel that is going to happen very often.

Q: Dr. Robinson, you requested this information, would this process satisfy that? A: Yes.

The idea is that as questions come up, when you get the answers, that may prompt more questions, so we will have that dialogue of forwarding the answers by blind copying everyone to ensure that there is no back and forth and we don't move into Sunshine violation.

Q: Will the answer go only to the Council member that asked the question?

A: No, it will go to everybody but then you all won't be able to reply back and forth.

Comment: Jose Luis Rodriguez, Esq. stated that his only concern is that with any of the questions, when we share the answer with everyone you might be tipping the hand of that Board member that may be leaning on an item and we have to be careful with this. He feels more comfortable with a member asking a question and your answer only to that member.

Comment: That is how the School District has been operating for decades.

Comment: Commissioner McKinlay stated that if it's a question that all of the members of the Board are asking, maybe something was missing from the agenda item. She is not comfortable with this idea.

Comment: Jose Luis Rodriguez, Esq. stated that he doesn't care who asked the question, he does not want to be copied on the answer. If he has his own questions, he will ask.

Comment: Lisa Williams-Taylor suggested that we have the questions asked brought to the Council meeting.

Comment: Commissioner McKinlay stated that she doesn't want to get the questions before the meeting and suggested that the questions are not emailed out as part of the packet.

Comment: Jose Luis Rodriguez, Esq. stated that we should have extra copies of the answers at the Council meeting in case someone in the audience is interested in seeing them.

Comment: Lisa Williams-Taylor stated that we will get the answers to whoever asked that question and then we bring the collection of the questions and answers to the Council meeting or we can have Council members asked those questions at the Council meeting.

Comment: Thomas Sheehan stated that distributing these at the Board meeting works. Board members would have them at their seats.

Comment: Commissioner McKinlay stated that if she would have a list of all the questions everyone asks before a Commissioners meeting, there will be no time to hold a Commissioners meeting. She likes the idea of having a central location to send the questions so that the CSC team can see it all at once, but she thinks this adds an extra duty to staff and that it is not necessary.

Comment: Debra Robinson, M.D. stated that this is about transparency. For the School District, they have questions attached to the agenda, so you can see all the questions that have been raised.

Comment: Jose Luis Rodriguez, Esq. stated that maybe this works, but the General Counsel should state if this works.

Comment: Debra Robinson, M.D. stated that her intention is to have the questions being part of the record, it is not intended to have a conversation outside of the Sunshine Law. Each of us has different views, so this would be something that would provide us with the opportunity to see something that I would not see, so if a member asks a question it can make another member stop and think differently.

Comment: Jose Luis Rodriguez, Esq. stated that the more he thinks about this, even posting it as part of the agenda, may not pose an issue, but he refers to the General Counsel for his advice.

Comment: Thomas Sheehan stated that we don't have the same system as the School District has to be able to do that. They have a very sophisticated agenda system. We post the agenda and he doesn't think there is a way to post these questions publicly. What he is hearing is that the Board in general would not get these. There will be a uniform place you can send your questions and individually you would get the answers and it's up to the Council member when an issue comes up whether you want to raise a question and get answer or not.

Thomas Sheehan recommended that it does present the potential for violating the Sunshine Law because of court decisions normally you can't have communication between Board members outside a public meeting. There is provision that allows you to send something in writing to all the Board members and you can do that, however, they cannot respond. The system of questions and answers, though, he thinks opens up real possibilities of a conversation in effect going back and forth.

Comment: Debra Robinson, M.D. stated that we can blind copy members of the Council so that they cannot respond to that.

Comment: Thomas Sheehan stated that if we can see the answers and that generates another question, that is where there is a potential of violation.

Q: Is this referring to when Council members questions are sent to everyone, or is it a request for a clarifying question that came in and we are sharing the response? These are very different things.

A: Debra Robinson, M.D. stated that her intent is two pronged. To limit the amount of time spent asking questions and secondly to make that information shared.

Comment: Thomas Bean stated that he doesn't see any need for sharing because Council members have individual questions sometimes based on personal interests. Usually the answers are shared as a follow-up.

Comment: Debra Robinson, M.D. stated that her point is that we tend to operate in a more isolated fashion than what she is used to.

Comment: Would we be comfortable with questions coming in and we send the question directly to the individual that has asked the question? Do we feel comfortable with providing the list of questions and answers and having them available to individuals at the Board meeting?

Q: What is the difference if a Board member calls the CEO directly and asks for a specific piece of data? Judge Kroll stated that she is not in favor of this.

Comment: Lisa Williams-Taylor stated that in the past, when a Council member asks a question, we include it in the CEO Report if they ask it to share with the Board.

Q: Is this a question that is asked at a meeting?

A: No, an individual asks a question and I ask if they want to share with the other Board members and if they say yes, we include it in the CEO Report.

Comment: Jose Luis Rodriguez, Esq. stated that we should present questions at the Board meeting as part of the discussion. He thinks it creates a grey area and that is when you get in trouble. He agrees with transparency, but getting the questions at the Board meeting, if there is any possibility that it could tip a decision, he is very sensitive to this and he would rather not do

it. It may mean longer Board meetings, unfortunately, but that is the purpose of discussions during a motion.

Comment: So, we will make the email address for questions available. Elsa will send it out when we send the meeting invitations. For the Board meeting, this will be embedded within the email so that it is easy to know if you have a question, where to go to post it. It will come to Lisa, and she will respond directly to the individual asking and then it will be up to each individual or Board member to bring those questions forward if they feel that that is something that all members need to hear before a vote is taken.

Comment: Debra Robinson, M.D. wanted to make sure that she is clear that she is the only Board member that thinks that everybody should get that information at some point in time. She wants to see what other Council members see. She learns from others and clearly she sees some things and others see other things. She thinks it's good to have collective thought and she doesn't think it violates the Sunshine Law. The School District also gets hard copies of the Q&As before the meeting, and it is posted electronically and she doesn't see why it can't be posted electronically here even though we don't have the same system.

Comment: Chair Weber stated that he thinks differently and enjoys that in our meetings when people have questions, they are discussed in our meetings and if there was a question and a request of data, we would get that data as part of being prepared for the meeting. Asking ahead of time so they are prepared to present to your question at the meeting is very beneficial but to have a full list of questions or issues would make us have very long meetings.

Outreach Media

Q: Debra Robinson, M.D. asked regarding media outreach, if there is any specific outreach for the African-American population? She sees Creole and Spanish.

A: John Bartosek stated that a number of the radio stations that are in the Hubbard Media Group have a break-down of African-American audiences. He doesn't have this with him today but those radio stations do have metrics and they count African-American audiences, as well as Hispanic. Christine Potter stated that Hubbard Media Group has X102.3, which is primarily an African-American urban listening station, as well as BEATS.

Every station has very unique listening audiences and we can bring a break-down of each.

A: Debra Robinson, M.D. stated that our data shows the population that we most are trying to improve the circumstances are for African-American. The outreach doesn't tell her that.

9. Legal Reports

Thomas Sheehan reminded everyone that we have our TRIM hearings and Council meetings in September. The first one is September 12, the Council meeting that day will be at 4:30 pm and the TRIM hearing at 5:01 pm. The second is on September 19 with the TRIM hearing at 5:01 followed by a very short Council meeting. Also, on September 12 we will have a PPC meeting. The reason we changed the date on the second meeting was to get at least 6 members without the Judge, who cannot, by statute, vote on the millage. 2019/2020 Great Ideas Initiative Funding Decisions

SUMMARY:

Since 2016, CSC has funded 70 initiatives supporting Palm Beach County children and their families, investing over \$1.9 million dollars through the Great Ideas Initiative (GII). This year is the 4th funding cycle and we incorporated a few modifications, including:

- Reducing the award cap to \$35,000 due to the availability of unexpended dollars,
- Heightening awareness through targeted marketing strategies,
- Implementing a fully-electronic application process, and
- Inviting the participation of three external professionals on the review team.

As part of this year's initiative, CSC sponsored its first GII Networking Breakfast Event, welcoming more than 50 attendees, including past and current GII awardees, CSC-funded provider agencies, community partners and staff. It was an opportunity to learn from each other about the vast programs and services helping children to grow up healthy, safe and strong.

In response to the expressed interest of the Council and local community-based nonprofits, CSC implemented the 2019 Great Ideas Initiative Capacity Building Pipeline (GII CBP) providing two additional years of resources and opportunities for selected Great Idea Initiative (GII) awardees to improve and enhance their ability to deliver their mission now, and in the future. This initiative is viewed as an investment in the effectiveness and future sustainability of growing nonprofit organizations.

CSC also initiated its 2019 Grassroots/Student-led Grant Making Pilot, modeled after the Brooklyn Community Foundation Neighborhood Strength Initiative to create a new model for neighborhood grantmaking that positions residents as key decision makers in local investments. This project was designed to increase CSC's engagement and investment in the Glades neighborhoods (Belle Glade, South Bay and Pahokee) through shared leadership with the Student ACES organization, a 2017 GII awardee. Working in collaboration with Healthier Glades, BRIDGES, City officials and other stakeholders, residents young and old identified key components for creating a youth-centered community. Through an RFP process, the youth from Student ACES awarded grant dollars to support those initiatives designed to improve conditions leading to a healthy, youth-centered community.

2019 Great Ideas Initiative

CSC received 57 applications for the 2019 Great Ideas Initiative totaling \$1,363,914.92. Five (5) applications were removed from consideration for failure to meet eligibility requirements. The remaining 52 proposals were reviewed and rated by a 7-member team comprised of three external and four internal reviewers. Since the applicant organizations were small in size and capacity, CSC added

15% to each funded amount for indirect costs to assist with administrative expenses associated with their project.

We are pleased to announce 16 organizations were selected, with individual awards ranging from \$11,500 to \$34,500, bringing the total 2019 GII awards to \$489,008.92. A list of the funded organizations and their great ideas is attached.

2019 Great Ideas Initiative Capacity Building Pipeline (GII CBP)

In July 2019, Children's Services Council announced a new opportunity to provide additional grant funding to eligible 2017 and 2018 Great Ideas Initiative (GII) awardees who were still successfully operating their funded programs/services. The objective of the GII CBP is to support ongoing organizational development so agencies can achieve their mission and deliver strong child-centered programs and services in Palm Beach County. The GII CBP grant was designed to:

- Assist organizations interested in building their capacity by enlarging the organization's footprint or ability to more effectively and efficiently serve children and their families;
- Support up to six (6) successful applicants through combined funding of (a) up to \$20,000 earmarked for capacity building supports and (b) an amount not to exceed \$30,000 for organization's original GII funded program; and
- Provide consideration for a second year of GII CBP funding in 2020 to those awardees who successfully implement their capacity building plan and maintain their funded program, subject to available funding and Council approval.

CSC received 26 applications. Two (2) applications were removed from consideration for failure to meet eligibility requirements. The remaining 24 proposals were reviewed and rated by an internal review team of five (5).

We are pleased to announce 6 organizations were selected, with individual awards ranging from \$47,400 to \$50,000, bringing the total 2019 GII CBP awards to \$294,095. A list of the funded organizations and their capacity building needs is attached.

FISCAL IMPACT:

The Council previously approved up to \$800,000 of unexpended funds in the CSC budget to be used for the Great Ideas Initiative and the Great Ideas Initiative Capacity Building Pipeline. The total of the two awards is \$783,103.92. The Council also approved \$50,000 for the Grassroots/Student-led Grant Making Pilot (described in detail in the CEO Report).

Resolution #19-021 Authorizing Funding for BeWellPBC Behavioral

Health Collective Impact

SUMMARY:

BeWellPBC is a countywide, collective impact initiative to advance and transform behavioral health for children and families. The focus is on increasing and improving interagency coordination and alignment of behavioral health services in Palm Beach County and more widely engaging community members in innovative solutions to improve the health and wellness of residents. With intent to create a community in which every person in Palm Beach County feels hopeful, supported, connected and empowered, BeWellPBC is engaging residents to direct its work with a focus on health equity.

CSC has been involved in this initiative since its inception, after the completion of a county-wide behavioral health needs assessment in 2017 and a series of community summits in 2018. CSC is a member of the Stewardship Council, a blend of 50% providers, professionals, system partners, funders and elected officials and 50% residents who have been directly impacted by behavioral health issues or are leaders or influencers in their communities and neighborhoods.

BeWellPBC is working with all system partners and community members that have joined together to form the collective initiative. Palm Health Foundation in West Palm Beach serves as fiscal agent and provides support to BeWellPBC's Executive Director and Project Coordinator. Confirmed funding partners for Years 2 and 3 include the Celia Lipton Farris and Victor W. Farris Foundation, Community Foundation of Palm Beach and Martin Counties, and Palm Health Foundation. Additional entities such as Southeast Florida Behavioral Health Network, Palm Beach County Community Services, Quantum Foundation, and United Way are committed to the partnership.

The initiative is already drawing national attention. BeWellPBC was chosen as 1 of 6 communities nationwide by ReThink Health, an initiative of the Rippel Foundation and a thought leader in the health philanthropy field. They will provide free technical assistance and capacity building support over a two-year period as part of its pilot program, "Pathways for Transforming Regional Health." The pilot is a model for accelerating large scale health-related change and is funded by the Robert Wood Johnson Foundation.

Efforts of BeWellPBC will focus on ensuring coordination and collaboration among existing practices and services, integrating behavioral health efforts and practices where possible, innovating efforts to fill identified gaps in a community culture of care, and engaging and mobilizing the community to build a supportive community culture. There is work underway to identify solutions to meet behavioral health workforce demands and to develop a ready workforce that reflects the face of our community. Current efforts also include promoting care and systems coordination, involving CSC, Southeast Florida Behavioral Health Network, and The School District of Palm Beach County.

The Community Solutions Team is identifying opportunities for mobilizing residents and building community capacity, and working with residents to create BeWell Clubs in communities to encourage advocacy, education, resource-sharing, and stronger social support systems. Future actions involve strengthening interagency networks, promoting equitable access to services, and ensuring that people have choices for care.

This funding request is to partner in accomplishing the transformative work of BeWellPBC. The work of BeWellPBC aligns with several strategy recommendations from CSC's Strategy Review and Allocation Analysis process presented to Council in June 2018. This work supports promoting resiliency and supporting families on their path to self-sufficiency, as well as facilitating access, engagement, and reducing barriers to behavioral health and support services. Community members are actively involved in the governance of this collective impact. CSC's funding will be utilized for initiative communications, consultation with national experts, staff salaries and benefits, and office administration.

FISCAL IMPACT:

The total cost of funding this item for FY 2019-20 is \$50,000 and for FY 2020-21 is \$50,000, or \$100,000 for FY 2019-2021, subject to the Council's approval of TRIM and the budget process.

The funds to support this agenda item are budgeted in the Program Division strategy budget in the BeWellPBC line item.

RECOMMENDATION:

I recommend the Council approve Resolution #19-021 providing funds to Palm Health Foundation as fiscal agent for BeWellPBC not to exceed \$50,000 per year for a two-year period totaling \$100,000, subject to the Council's TRIM and budget process for each year.

Nonrenewal of Counseling for Parents and Young Children contract with Housing Partnership, Inc. dba Community Partners of South Florida

CSC STAFF: Tina Hallyburton, Program Officer

SUMMARY:

In December 2018, in an effort to address the wait list for mental health counseling, staff requested a waiver of CSC's procurement policies and sought approval to enter into a contract with one or more agencies to serve as back-up providers. CSC contracted with Housing Partnership, Inc. dba Community Partners of South Florida (CP) and Children's Case Management Organization, Inc. dba Families First (FF) effective January 15, 2019 through September 30, 2019.

In April 2019, staff requested approval to extend this procurement waiver for these back-up contracts for FY 19-20. Since that time, CSC's two original providers (Center for Family Services and Center for Child Counseling) have hired additional staff, and FF has been able to accept clients from the wait list. However, due to issues beyond its control, CP has struggled with staff capacity issues, has not been able to enroll any clients under this contract since June, and has only been able to serve 5 of the 25 clients they agreed to serve. As a result, staff decided not to renew this contract for FY 19-20. This decision does not negatively affect their ability to be considered for future funding.

Staff will continue to monitor the number of referrals and determine if any other measures are needed to address the needs of the clients within the HB System.

SUMMARY:

In February 2014, the Council created the Finance Committee and, in doing so, transferred to it the tasks of the Audit Selection Committee, more familiarly known as the "Audit Committee". In addition to selecting the auditor, the Finance Committee's basic responsibilities include: providing recommendations to the entire Council for fiscal responsibility; regular review of the Council's revenues and expenditures, balance sheet, investments and other matters related to its continued solvency; ensuring the maintenance of an appropriate capital structure; and overseeing the maintenance of organizational-wide assets, including prudent management of organization investments.

In this past legislative session, HB 7035 revised Florida Statute 218.391 to change the title of Audit Committee to "Auditor Selection Committee". The primary purpose of the Auditor Selection Committee is to assist the governing board (i.e., the Council) in selecting an auditor to conduct the annual financial audit. To do this, it must:

- a. Establish factors used for the evaluation of audit services to be provided by a public accounting firm
- b. Publicly announce Requests for Proposals
- c. Provide interested firms with the Request for Proposal
- d. Evaluate proposals provided by qualified firms
- e. Rank and recommend in order of preference no fewer than three firms deemed to be the most highly qualified to perform the required services after considering the factors established pursuant to item a above.

Upon receiving the recommendations from the Auditor Selection Committee, the Council shall select one of the firms recommended by the Committee. (The selection process is based on the standards established by the Committee – attached, as Exhibit A are the three scenarios that the statute provides for the Council to choose an auditor, based on the standards selected by the Audit Committee.)

The statute provides that the Auditor Selection Committee must have at least three members, at least one of whom must be a member of the governing board, who shall serve as Chair – employees of the governmental entity may not serve as members but may serve in an advisory capacity. Non-Council members may also serve. As presently constituted, the Finance Committee meets the requirements of this statute.

Exhibit "A" CHILDREN'S SERVICES COUNCIL OF PALM BEACH COUNTY

Selection of Auditor Selection Committee Recommended Firms by the Council (218.391(4), Florida Statutes)

The governing body shall inquire of qualified firms as to the basis of compensation, select one of the firms recommended by the auditor selection committee, and negotiate a contract, using one of the following methods:

- (a) If compensation is not one of the factors established pursuant to paragraph (3)(a) [tasks of the Auditor Selection Committee] and not used to evaluate firms pursuant to paragraph (3)(e) [tasks of the Auditor Selection Committee], the governing body shall negotiate a contract with the firm ranked first. If the governing body is unable to negotiate a satisfactory contract with that firm, negotiations with that firm shall be formally terminated, and the governing body shall then undertake negotiations with the second-ranked firm. Failing accord with the second-ranked firm, negotiations shall then be terminated with that firm and undertaken with the third-ranked firm. Negotiations with the other ranked firms shall be undertaken in the same manner. The governing body, in negotiating with firms, may reopen formal negotiations with any one of the three topranked firms, but it may not negotiate with more than one firm at a time.
- (b) If compensation is one of the factors established pursuant to paragraph (3)(a) [taskes of the Auditor Selection Committee] and used in the evaluation of proposals pursuant to paragraph (3)(d) [tasks of the Auditor Selection Committee], the governing body shall select the highest-ranked qualified firm or must document in its public records the reason for not selecting the highest-ranked qualified firm.
- (c) The governing body may select a firm recommended by the audit committee and negotiate a contract with one of the recommended firms using an appropriate alternative negotiation method for which compensation is not the sole or predominant factor used to select the firm.
- (d) In negotiations with firms under this section, the governing body may allow a designee to conduct negotiations on its behalf.

PROCLAMATION

DECLARING THE MONTH OF SEPTEMBER 2019 AS INFANT MORTALITY AWARENESS MONTH

WHEREAS, infant mortality – the death of a child before the first birthday – is a widely accepted measure of a community's well-being and continues to be a major social crisis and health care concern in our state and county; and

WHEREAS, the overall infant mortality rate in Palm Beach County increased slightly in both number and rate in 2018 compared to the previous year, with 73 deaths in 2018 and a total rate of 4.8 per 1,000 live births; and

WHEREAS, the black infant mortality rate in Palm Beach County increased in 2018 from the previous year but remained below the statewide level and is also lower than all the other urban counties in the state except Broward; and

WHEREAS, pre-conception and inter-conception health and early, consistent prenatal care are proven factors influencing premature birth and low birthweight; and

WHEREAS, racial disparities still persist for children in their first year of life in Palm Beach County, with higher rates for black non-Hispanics, all Hispanics, and Haitians compared to the rate for white non-Hispanics, and with the racial disparity gap in Palm Beach County increasing to the highest level in the past six years; and

WHEREAS, racism has a devastating effect on the health of women of color, and that of their babies, documented in a U.S. National Institutes of Health review of scientific studies that confirms a strong link between racial discrimination and poor birth outcomes; and

WHEREAS, ensuring expecting families have access to health care and supportive services will help reduce infant deaths and racial disparities; and

WHEREAS, Palm Beach County recognizes the importance of designating a time devoted to increasing the public's awareness that all new parents deserve a healthy, safe and strong future for their baby;

NOW, THEREFORE, BE IT PROCLAIMED BY THE CHILDREN'S SERVICES COUNCIL OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 12th day of September 2019, that the month of September 2019, in Palm Beach County, is hereby declared as Infant Mortality Awareness Month.



Follow-Up To April 25, 2019 Council Meeting

We want to further inform the Council that the article now has been added to the EveryParent app and website. This is the link on the website:

We also added push notifications on the topic to families of various ages to remind them periodically about the School District, County and Municipal resources.

Program Updates

2019 Grassroots/Student-led Grant Making

The purpose of the **Grassroots/Student-led Grant Making** Pilot is to promote societal healing and transformation by helping to ensure buy-in and accountability for shared goals and strategies within the Glades communities. Modeled after the Brooklyn Community Foundation Neighborhood Strength Initiative, this Pilot was designed to:

- Create a new model for neighborhood grantmaking that positions residents (students) as key decision makers in local investments,
- Affect change through the power of young people,
- Foster effective and community-determined resource allocation,



- Strengthen resident-controlled associations and local non-profits helping people with shared interests work collectively to improve their blocks, neighborhoods, or communities and be a stronger voice for change and community vitality, and
- Bolster CSC's relationship, engagement and investment in the Glades neighborhoods (Belle Glade, South Bay and Pahokee) through shared leadership with the Student ACES organization, a 2017 GII awardee.

Through an RFP process, the youth members of Student ACES Glades, in collaboration with Healthier Glades, BRIDGES, City officials and other stakeholders serving as Advisors, engaged residents young and old to identify key components for creating a youth-centered community. The student-led Steering Committee (Glades Student Grant-making Association) was comprised of ten (10) high school athletes from Belle Glade, Pahokee and South Bay. With the support of Student ACES leadership and a local consultant, students learned how to collect, examine and interpret qualitative data to inform their decisions.

After weeks of resident and student interviews, the Students landed on three (3) focus areas they believed would improve conditions leading to a healthy, youth-centered community: **Community Safety, Building Community Respect, and Increasing Community Trust and Accountability**. They also included an "Other" category to ensure all great ideas would be considered. Non-profit organizations and organized neighborhood groups could apply for up to \$5,000 and \$2,000 respectively.

To hold themselves accountable to the process, the students created their own rules of engagement, job description and stipend payout schedule. Numerous hours were spent determining reasonable selection criteria, writing the RFP, promoting the initiative and conducting an information session (on site and via Facebook live). In preparation, the students also reviewed, discussed and scored faux applications provided by CSC staff.

Awardees are in the process of being selected and approved by CSC for funding. The Students will present a summary of their experiences with Student-led Grantmaking to the Council at the December 5th Council Meeting.

STEAM Initiative

Based on the results of an exploration process and recommendations from stakeholders, CSC has continued to invest in STEAM programs. This includes STEAM Coordinator positions at Palm Beach State College and Prime Time of Palm Beach, increased access to STEAM focused Expanded Learning Opportunities, and funding Green Mouse Academy to be the FIRST LEGO League Partner of South Florida.

During the June 2018 Planning Session, CSC's Council expressed support for current efforts and continued investment in increasing the reach and access of STEAM activities in community-based settings. In this past year CSC launched the CodeCombat Project, delivered by STEM HQ, to provide challenge-based learning modules for engagement in STEAM. The project targeted under-represented students and was offered at several community-based settings across the county, reaching a total of 300 students.

Additional programming to expose underserved children to the STEAM field was made available throughout the summer. STEM HQ delivered a highly immersive beginner's camp designed for youth who are just getting started and have a passion for technology. Over 140 students at community based summer camps participated in Programming (CodeCombat), Electronics (building systems using microprocessors and custom circuits), Computer Aided Design (CAD) (including the use of 3D printing and laser cuts) and Building (robot building).

Green Mouse Academy (GMA) provided a great introduction to the FIRST Lego framework by teaching the core values of cooperation and teamwork while learning and testing the robot models. They provided equipment, specialized facilitators and all required resources and materials in order to set up First Lego League teams at several community centers. The summer program served over 50 students and culminated with an internal site competition. For those programs interested in forming a team in a sanctioned Qualifying Tournament for the 2019-2020 season, GMA is poised to assist with their preparation and participation.

For the coming fiscal year and in partnership with Prime Time, a multi-faceted and comprehensive program for delivering STEAM activities to students from 3rd to 8th grade in community-based afterschool settings was developed. This approach offers opportunities to do the following: provide access to STEAM focused learning environments, spark family engagement and exploration into STEAM related fields through career exploration, and create a connection to the business community and immersion into STEAM-rich programs through targeted expanded learning opportunities. It is also a skill development opportunity for out-of-school time practitioners with hopes to increase skills in delivery of informal science. This year round initiative consolidates and expands the disparate STEAM programs currently funded by the Children's Services Council of Palm Beach County.

"When a woman becomes pregnant, the body will work to nourish the growing baby with whatever resources it has, which is why it's so important to give your baby the best foundation possible by eating healthy, maintaining a healthy weight and exercising before you try to conceive," says Belci Encinosa, director of Community Engagement for Healthy Mothers, Healthy Babies Coalition of Palm Beach County. "We see moms who are overweight and even underweight, and not being at a healthy weight from the start, sometimes the body will reject the baby."

The April 2019 Council presentation on the EveryParent campaign included plans to add videos to the app. To date, Communications staff produced more than 165 new videos, primarily in the "Ask an Expert" series. To keep users logged into the app, we developed a new feature allowing the videos to be viewed "in the app" without switching over to other sites, like YouTube.com. We believe this feature will more easily allow users to continue to review EveryParent information.

The first set of videos have been placed in the "Year 0" Prenatal section of app and became available in late August. We will promote these new videos to users and potential users, and we will continue to add more videos in coming months in other age categories.

Achievements

Energy Star Certification



This month, CSC earned the EPA's ENERGY STAR certification for 2019. ENERGY STAR is the only environmental program in the United States that certifies energy efficiency based on actual, verified energy performance and objective measures of performance, providing a guarantee of savings. ENERGY STAR certified buildings use, on average, 35 percent less energy than similar buildings nationwide.
