The committee recommended that the Council approve the proposed tentative budget for Fiscal Year 22-23. The Committee also recommended that the Council authorize staff to provide the Property Appraiser the tentative millage rate of .5586, which is the rolled-back rate, with staff having the authority to adjust the millage rate to a revised rolled-back rate in the event final figures from the Property Appraiser vary from the preliminary figures used to calculate the rolled-back rate.

Recommendation: I recommend the Council approve Resolution #22-015 authorizing the Chief Executive Officer to enter into an amendment to the agreement with Transportation Services, 4R Services, LLC dba Metro Taxi dba Yellow Cab, to increase the allocation by an amount not to exceed \$78,000 for a total FY 21-22 annual allocation not to exceed \$308,168 effective July 1, 2022.

2. <u>Resolution #22-016 Authorizing Increase in Funding for Camp Scholarships</u>

Recommendation: I recommend the Council approve Resolution #22-016 authorizing the Chief Executive Officer to enter into an amendment to the agreement with Friends of Youth Services and Palm Beach County, Inc. to increase the funding by an amount not to exceed \$500,000 for FY 2021-22 to allow more scholarships to be made available to the children on the wait list. The total approved allocation will increase from \$3,900,000 up to \$4,400,000.

Recommendation: I recommend the Council approve Resolution #22-017 authorizing a waiver of procurement and authorizing the CEO into the necessary agreement to support the funding collaboration with Palm Beach County Youth Services Department for specified Safety and Justice programs for the period of October 1, 2022 through September 20, 2025 in an amount not to exceed \$352,524 subject to the Council's annual budget and TRIM process.
